Bone marrow smears show presence of small to intermediate sized lymphoid cells.

Interpretation:

On flow cytometry of bone marrow, approximately 10 % B lymphoid cells gated on SS vs CD19 showing expression for CD45, CD19, CD20 (bright), CD22, CD11c, CD25, CD48, CD200, Kappa and Lambda. Dim expression is seen for CD23, CD38, CD103 and CD123

Negative expression is seen for CD3, CD4, CD5, CD8, CD10, CD16, CD34, CD56, CD81 and CD138.

The scatter parameters and antigenic expression profile of bone marrow reveal 10% B cell Lymphoma cells with Hairy Cell Leukemia immunophenotype.

Advise:

Corrlation with bone marrow aspiration/ biopsy findings.
