## Interpretation

Polyclonal increase seen in autoimmune diseases (systemic lupus erythematosus, rheumatoid arthritis, Sjögren's syndrome), sarcoidosis, chronic liver disease, some parasitic diseases and chronic or recurrent infections.

Monoclonal gammopathies seen in IgG type multilple myeloma, lymphomas, leukemia, and other malignancies.

Hypogammaglobulinemias, IgG deficiency may be genetic as in severe combined immunodeficiency or acquired as in AIDS. A decrease in IgG also occurs as a result of thermal burns, nephrotic syndrome, protein losing enteropathies and non-IgG myelomas.
